

General Terms & Conditions of Summer Shopping Marathon:

1. Promotion period is from 1 July to 31 August 2026. Sales transaction and reward redemption must fall on the same day. Receipts that are out of the Promotion Period are not accepted.
2. Customers are required to download Hong Kong Times Square APP and register as Team Times member to join this promotion and enjoy the rewards. Each customer can register as Member ONCE only. Times Square Limited reserves the right to request Member to present their proof of identity for verification.
3. Each member can only redeem once per day and can only redeem rewards a maximum of 10 times during the entire promotion period. **Each valid receipt is eligible for a single redemption registration and cannot be used across multiple reward programs**, with the exception of VIC points accumulation and free parking offer.
4. Rewards have a limited total quota for the entire promotional period, available on a first-come, first-served basis while stocks last.
